



Memories of Jim McKinstry

I knew Jim McKinstry before I joined the Tin Lizzies. He and Mary Jo attended the same church Barbara and I did. However, he had never mentioned that he was involved with Model T's. Back in the 1990's a friend and I attended the State Fair. It happened to be the day the Tin Lizzies were there for Model T day and there was Jim! I had thought about getting a Model T for a long time and seeing Jim at the State Fair got me started by joining the Tin Lizzies. He also was the person who gave me my first Model T driving lesson by taking me down to the place on Central where the Telephone Truck was stored and letting me drive it around the lot. He was very tolerant of all the mistakes I made!

I remember Jim telling me about how, as a Telephone Pioneer, he found out that the Telephone Truck was stored in Albuquerque. It had been outside for several years and was, as you might expect, in bad shape. He took primary responsibility for getting the body and running gear restored. His work resulted in the unique vehicle which has become such a great part of our club. For many years Jim drove the Telephone Truck to many parades. He loved driving the truck and talking about the truck's history.

Jim's work as the "coil man" is well known to many of our members. He was the guy who could restore the coils for member's Model T's. His work included replacing the points and condensers, and doing the intricate woodworking that was required to make new wooden boxes for the coils that were just like the originals.

Whenever he was able to go, I took Jim to the Tin Lizzies' meetings. He enjoyed seeing his friends and they were always glad to see him and the smile that lit up his face. He was awarded the clubs' Outstanding Member Award. His running joke with Don Souther was legendary. If asked how old they were, they would always point at each other. No one wanted to spoil the joke by finding out who was right.

I know many of you have other wonderful memories of Jim. These are just a few which I hope will help us remember what a great guy Jim was.

Remembering Laura Kammerer (1955-2016)

Laura and her husband, Dave Ferro joined the Tin Lizzies in the spring of 2013. Both of them had recently retired from Florida state historic preservation jobs. They were splitting time between their home in Tallahassee and Albuquerque where Dave had grown up. Laura's roots were in Pennsylvania and Florida where she had lived all of her adult life. They shared many common interests including a passion for attention to detail and preservation of the past. One interest they shared was in historic railroad preservation. They spent many summer vacations volunteering on various projects with the Friends of the Cumbres and Toltec Scenic Railroad in New Mexico. They collected and restored rail motorcars and belonged to a local rail car club. These vintage rail cars were used to inspect the track, had small gasoline engines and travel along comfortably at 25-30mph-like Model Ts. In early 2013, during one of their trips to Albuquerque, Dave was in the shop at Rich Ford when he noted that the Tin Lizzies had their Ts on display. He moseyed over to see the cars. Ambassador Mark Wing showed his T to Dave and encouraged he and Laura to join the Tin Lizzies. Within a short time, they had joined as members, started working in Larry's shop, had purchased a 1918 Depot Hack from Dean Van Doren as well as a new pickup truck/ trailer to haul it around! During the 2014 Tucumcari tour they came prepared to drive their T but it lost a freeze plug on the way to the first night "Happy Hour." The next morning, they moved into the back seat in the Duncan's touring. This past May, Laura passed her Lady's Model T driving test. Later that month, they brought their depot hack to the Coronado Monument 75th Anniversary celebration and were especially interested in the archaeology and artifacts theme that parked the Ts among the ruins. The next month, on the Silver City tour, their depot hack had a rebuilt engine, a new Ruckstell, revarnished spokes and other corrected details. Dave & Laura were dressed in vintage attire. During the summer Laura and Dave worked with the Duncans and the Ross' to complete planning the August Chama tour. Unfortunately, Laura and Dave were unable to participate in the tour as Laura's health declined and she was diagnosed with advanced cancer. Despite intensive treatment and incredible courage, she lost the battle. We are deeply saddened to have lost Laura this past month and want Dave to know how much we will miss her cheerful presence in the Tin Lizzies and look forward to his continued participation in the club.

Proposal to Amend two sections of the current Tin Lizzie of Albuquerque Bylaws (Adopted April 24,1979, Revised October 25, 1994, Amended July 28, 1998) Article III Members, Section 2. Life Members (a, b, c) and Section 4. Special Fund. Proposal dated April 10, 2016

Proposed by The Tin Lizzies of Albuquerque Board of Directors at their meeting April 10, 2016

Goal: Clarify and Simplify the Life Membership requirements for all Club (The Tin Lizzies of Albuquerque) members and to delete the Special Fund from the Bylaws

Reasons: This year, in 2016, the Club has 16 Active Life Memberships of which 13 have reached the 80-year age requirement of the current Bylaws (Article III, Section 2, c). The Club membership is aging and 7 more currently Active members will be eligible for Life Membership next year (2017). The Club benefits by recognizing the contributions of our senior members. In the current Club Bylaws "Voting Spouses" are required to pay annual dues of \$3/year, regardless of age for an undefined period of time. Payment and collection of the Life Member "Voting Spouse" annual dues has been inconsistent for many years. The status of a surviving Spouse was also ambiguous, especially if they were under the age of 80. Currently, many member Spouses have assumed major responsibility in the Club through their leadership role in Club activities and service as Club Officers and Directors.

In the current Bylaws, wording relating to payment of future annual dues was inconsistent among subsections, a. b. and c.

Article III, Section 4 Special Fund for Paid Life Memberships was never set up and does not currently exist.

All current "Paid" Life Membership(3) dues have been deposited into the general Club treasury.

For these reasons, the current Board of Directors is recommending wording changes to Article III, Section 2 (Life Members) and that Section 4 (Special Fund) be Deleted. These changes clarify that all Life Memberships in the Club may include a Spouse for their lifetime. No annual dues will be collected from any Life Member or their Spouse. All "Paid" Life Membership funds will be deposited into the general club treasury account.

Parliamentary Process outlined in current Bylaws:

- (1) Article XII Amendments: These Bylaws may be amended at any meeting of the Club by a two thirds (2/3) affirmative vote of the voting members, provided that the amendment has been submitted in writing at the previous meeting or notice has been given in the Newsletter of the Club.
- (2) Article XI Parliamentary Authority: In all cases not provided for in these Bylaws or the Bylaws of the Model T Ford Club of America, the current edition of *Robert's Rules of Order, Newly Revised*, shall govern the proceedings of the Club.
- (3) Article VII Meetings, Section 3: Fifteen (15) members of the Club shall constitute a quorum.

Changes Proposed: Word deletions shown with Strikethroughs and additions in Bold Italics Article III Members

Section 2. Life Members

Members who are Founding Members of The Tin Lizzies of Albuquerque and who have paid \$120 dues to the treasurer special fund general Club treasury will no longer pay annual dues. Voting Spouse to pay \$3.00 per year may become a Life Member and pays no annual dues.

Members in good standing for four years of continuous membership who have paid \$150 to the treasurer special fund general Club treasury will no longer pay annual dues. Voting Spouse to pay \$3.00 per year may become a Life Member and pays no annual dues.

Members in good standing for four years of continuous membership who have reached the age of 80 years with no additional dues to be paid by December 31st become Life Members on January 1st of the next calendar year and will no longer pay annual dues. Spouse to pay \$3.00 per year may become a Life Member and pays no annual dues.

Section 4. Special Fund: A fund shall be created to control moneys collected for Life Members and disperse to the treasurer annually for dues for those Life Members

The Bylaw amendments if Adopted would read as follows:

Article III Members

Section 2. Life Members

- a.Members who are Founding Members of The Tin Lizzies of Albuquerque and who have paid \$120 dues to the general Club treasury will no longer pay annual dues. Spouse may become a Life Member and pays no annual dues.
- b. Members in good standing for four years of continuous membership who have paid \$150 to the general Club treasury will no longer pay annual dues. Spouse may become a Life Member and pays no annual dues.
- c. Members in good standing for four years of continuous membership who have reached the age of 80 years by December 31st become Life Members on January 1st of the next calendar year and will no longer pay annual dues. Spouse may become a Life Member and pays no annual dues.

On April 9, Linda Riel hosted T N'Vittles at Cracker Barrel. Four Model T's and 30 people attended the breakfast. Service was very good and the camaraderie as always was great. Thanks Linda





.Larry's garage was humming with activity after our club breakfast at the Cracker Barrel restaurant on Saturday, April 9th. Joining us for the first time this morning was James, a friend of Ken Carpenter. James owns a 1948 Chevy truck, so he's no stranger to older vehicles. Ken brought his fami-



ly's 1923 touring car (converted to a pickup truck) for adjustments to the transmission bands. At a previous work party, a shorted starter switch was fixed and the carburetor was cleaned. Once he truck could start reliably, the bands were adjusted and Ken and James were able to take it out for spin around Corrales. Skip Dunn trailered his 1914 Model T touring car from Los Alamos, NM to Larry's to install new tires on his wheels. Skip had salvaged the new Universal tires from the prop car used by the Santa Fe Opera. Dave M. and Kirby O. assisted Skip on the tire installation. The Lance family was hard at work on the family's 1919 engine restoration project. Phil was rebuilding his generator with a kit donated by Bill Hansen. The comprehensive kit included new bearings, field coils, insulators, and brushes. It will be as good as new once assembled. Phil's daughters Danielle and Jessalyn

received a lesson in line boring from Larry. These young ladies were shown how to operate Larry's large lathe and measured their machining progress with depth micrometers. This may be a first in the annals of the Model T hobby! We can look forward to an account of the Lance family engine rebuilding adventures in a published article in the future. Way to go Danielle and Jessalyn! Mark continued assembling his 1925 touring car engine/transmission. Larry had installed new Oilite bushings and modern oil seals on the hogs head. A generator was tested and it's ready for installation as is a newly rebuilt starter. The exhaust manifold had warped approximately 1/8" and Larry had created a fixture to bend manifolds back into shape. This clever fixture has centering holes corresponding to each of the exhaust port holes. The two holes nearest the threaded part of the manifold can be moved via fine-threaded bolts once the manifold is heated red hot. The majority of the heat is applied to the top of the manifold (where the metal is compressed). This procedure worked great for Mark's manifold, and Larry performed the same technique on Phil Lance's manifold as well. Phil's needed to be bent approximately 3/8" but the operation was successful with no cracking. The exhaust port gland rings now available will prevent this metal sagging problem in the future. TIN LIZZIES CLUB MINUTES April 28, 2016

The Tin Lizzies met in a regular monthly meeting on April 28, 2016 at the Vineyard, 6118 Edith, NE in Albuquerque. The meeting was called to order by president Mark Dominguez who led us in the Pledge of Allegiance. Members were welcomed.

The minutes were approved as corrected as related to the Treasurer's report. The MTFCA insurance information should be deleted and replaced with the following, "Marilyn Duncan gave the checkbook balance. Income and expenses since the last meeting was expense of \$186.00 for the telephone truck and trailer insurance."

Marilyn Duncan gave the Treasurer's report. We have received a \$200.00 donation to the club as a result of a trade between Skip Dunn and John Hayne. Thanks, gentlemen. Expenses were \$62.85 in raffle expense and \$130.84 for historian expense. Income of \$59.50 from the raffle, \$15.00 in dues, and a \$100.00 donation for our participation at the Brewhouse opening was reported. We have 12 new National memberships and they will be awarded a one-year complimentary membership in the local club. Club members indicated that they preferred reissue of the membership list quarterly or when there are major changes.

Committee reports were given. Dave Merewether reported that the NM Car Council met on April 27. The Oak Flats picnic will have the Drifters and Challengers car club as the sponsor. The Collector car show has no sponsor for the proposed July show and they are hoping to get that finalized. The May 15 car show will be at the Albuquerque Museum and will feature a collection of cars to tell the story of Route 66. Kirk Peterson and Dave Merewether will have two of the featured cars with their 1923 and 1926 Model Ts on display. The fall swap meet planned for September 23-25 will open registration for booths in July. The cost will be raised to \$30 this year instead of the previous \$25. Dave placed a 4 page listing of car shows that will be held during the coming month on the front table for anyone who was interested. The list is also on the NM Council of Car Clubs web page.

Kurt Peterson apologized for sending out an e-mail without the blind cc feature. Out of respect for our two deceased members, he deleted their names from the e-mail list.

Robbie Ross gave the newsletter report. Deadline for submissions for the newsletter is 8:00pm Sunday.
